#### **DANA UPDATE March 2008**

#### **DANA NEWS**

On January 9, 2008, DANA incorporated as a nonprofit corporation under lowa law by the filing of articles of incorporation with the lowa Secretary of State. This means that DANA now has a board of directors, a president, and a vice president in place of a steering committee, a chairperson, and a vice chairperson. Other officers are the secretary and treasurer. By incorporating as a nonprofit, DANA can reduce its postage costs for mailing of the newsletter. Also, DANA is required to file a report with the state every other year to keep its status as a nonprofit corporation.

On February 11, 2008, the DANA board of directors adopted corporate bylaws to govern the operation of DANA. The bylaws specify that every person over the age of eighteen who lives or owns a business or property in the Douglas Acres Neighborhood is a member of DANA. Payment of dues is not a requirement for membership; payment is considered to be a contribution to DANA. The bylaws define the boundaries of the neighborhood. The bylaws set the procedures for meetings and elections and the duties of the officers and directors. The bylaws can be amended only by the affirmative vote of a majority of the members at any meeting of members.


