SNOW PLOWING AND STREET PARKING

When Des Moines city trucks are plowing snow this winter, parking on any street in the Douglas Acres Neighborhood is prohibited by city ordinance. If your vehicle is illegally parked, it will be ticketed, may be towed, or may be buried by plowed snow. Keeping vehicles out of the way of the snow plows will allow our streets to be plowed more quickly and more thoroughly. In the winter of 2009-2010, our neighborhood participated in a pilot program that asked residents to voluntarily refrain from parking during snow plowing. The program will be expanded this year and in the areas where it is implemented, compliance will not be voluntary. The DANA board of directors at its September meeting voted to join in this program, and the board urges every resident to comply. Remember, street parking is prohibited only during snow removal operations, and the parking ban applies to all city streets in the neighborhood. The city will post signs that will serve as a notice to all residents.

HY-VEE OPENS NEW EVENTS CENTER AND HOSTS NATIONAL NIGHT OUT

The Hy-Vee store on East Euclid has converted the building that formerly housed the Goodwill store into the Eastside Events Center.
